#### WHAT WE DO

Habitat is an experienced developer, builder, mortgage lender, and advocate for housing affordability for diverse community members and groups. We also offer preparatory services from HUD-certified housing counselors to ensure potential buyers are ready for homeownership.

### **WHO WE SERVE**

Tacoma Habitat serves low- and moderate-income households making between 50 and 80% Area Median Income.



During the 2024 Legislative Session, we aim to support housing development by reducing barriers, expanding available funding sources, and prioritizing affordable housing at the state level. *We advocate for:* 

### **INCREASING FUNDING**

**Expand affordable housing funding sources** to serve households making up to 80% AMI to encourage diverse housing production that meets the need in our state.

**Create a sales and use tax exemption** for affordable housing providers. Tacoma Habitat projects an exemption could save nearly \$200,000 annually to put toward future development projects.

**Provide supplementary allocations to the Housing Trust Fund,** including the requested \$60M for affordable homeownership as recommended by the Department of Commerce's homeownership unit.

## **IMPROVING EQUITY**

**Invest in solutions that close the racial homeownership gap.** According to Commerce's recent Homeownership Disparities Report, approximately 144,000 BIPOC Washingtonians would need to become homeowners to achieve parity with the white ownership rates. We're partnering with the Tacoma Urban League and the Black Home Initiative to increase the pipeline of buyer-ready BIPOC community members. We urge the Washington State Legislature to support the Black Home Initiative's solutions this session.



We are pleased to announce that this project is well underway, with the first homes under contract and plans to acquire the next tranche of homes in 2024.
